A valid credit card MUST be on file, however if the bidder prefers to send a money order or check, they can do so as long as it is received within 5 days after completion of the auction. If a check or money order is not received, then the credit card will be charged. All purchases are subject to a 13 percent Buyer's Premium.
3. Once a bid is placed, it cannot be changed or withdrawn after 5pm on the day prior to Auction, due to processing time.
4. It is the responsibility of Absentee and Phone Bidders to use their own resources to determine the condition of the merchandise for themselves prior to placing their bids. Any statements made by staff or auctioneer to an Absentee or Phone Bidder are that person's OPINION only, and we make no guarantee as to the accuracy of their descriptions or statements.
5. In order to bid via telephone during the auction, advance arrangements must be made, and minimums (usually \$500) may apply. The amount of the minimum bid may change at the auctioneer's discretion. Bids under \$500 may be placed as an Absentee Bid. . This is due to the limited number of phone lines and staff. Live bidding on Internet Providers such as Live Auctioneers or Proxibid may also be available
